MALABAR CHARITABLE TRUST – OBJECTIVES

The Trust has been formed and functioning for public charitable purposes and the words "charitable purpose" mentioned herein shall have the meaning assigned to these words in section 2(15) of the Income - Tax Act, 1961.

Following are the purposes for which the income of the trust shall be utilized:

- (1)To provide facilities and assistance by way of medical relief to the sick, affected and infirm by supply medicines, undertaking treatments to the aged, sick and ailing who stand in need of such help.
- (2)To establish hospitals, dispensaries, clinics and nursing homes to cater to the medical needs of the poor and the underprivileged and to establish rehabilitation centers for the handicapped.
- (3)To encourage social, cultural and charitable well-being of individuals and the society as a whole.
- (4)To function as much as possible for national integration, propagation of human thoughts, protection of rights of women and other backward people of the society.
- (5)To foster and educate orphans and destitute and establish and maintain orphanages without any discrimination of caste and creed.
- (6) To establish, maintain and import educational and technical institutions, polytechnics, training schools technical and vocational training.

- (7) To provide financial assistance by way of grant, aid, scholarships etc. to poor, deserving students for proceeding with their studies.
- (8) To help girls in indigent circumstances for the conduct of their marriage.
- (9) To render all services required for the benefit, uplift and prosperity of all section of people without any discrimination of caste and creed.
- (10) To extend aid to persons affected by natural calamities like flood, draught, fire etc.
- (11) To receive aids, loans and deposits from central, state and foreign governments, semi-governmental bodies, corporations, other institutions and individuals.
- (12) To render social services by the construction of wells and bore wells, planting of trees etc.

MALABAR HOUSING CHARITABLE TRUST – OBJECTIVES

- (1) To help the poor and needy persons owning house plots to build house and also in appropriate cases help poor persons to purchase plots and build house thereon.
- (2) To work for the educational, cultural, social and economic development of the people of India.
- (3) To establish and run educational institutions of all kinds at all levels in all subjects including pre/lower/upper primary secondary/higher secondary schools, polytechnic, Industrial Training Centers, Teachers, Training Institutes and Colleges such as Arts and Science, Commerce and Management Studies, Medical, Para Medical course, Engineering, Agriculture, Veterinary, Law etc.
- (4) To establish and run social service institutions such as Orphanages, Health Clinics, Hospitals, Destitute Homes, Adult Education Centers, Youth Hostels, Community Centers, Libraries, Recreation Centers, Legal Clinics, etc. to ameliorate the conditions of the needy sections of the community.
